



# ICE European ESG Template (EET) solution

ICE offers high-quality, timely EET Data collected from thousands of primary sources and standardized into the ICE data model.

#### **Regulatory background**

The European ESG Template was created by FinDatEx (Financial Data Exchange Templates) with the aim to facilitate the exchange of critical ESG fund and regulatory data between market participants, enabling compliance with Sustainable Finance Disclosure Regulation (SFDR), Markets in Financial Instruments Directive (MiFID), EU Taxonomy Regulation and Insurance Distribution Directive (IDD) regulations.

Manufacturers of financial products started publishing **Level 2 sustainability classifications and suitability** in June 2022, in addition to Level 1 in 2021.

This information is delivered in the European ESG Template, and from January 2023 includes the fund's **Principal Adverse Impact (PAI)** data, EU Taxonomy alignment information and negative screening thresholds.

ICE's EET Solution assists clients in **achieving compliance** with:

- MiFID II questionnaire (ESG investment preferences), with the classification of sustainability categories for financial products, that delineates the following instrument types:
  - 7a Environmentally sustainable investments -Taxonomy
  - 7b Sustainable investments SFDR
  - 7c That consider PAIs
- SFDR product classification (article 8 light green, article 9 dark green and article 6 neutral), with the coverage of PAI (Principle Adverse Impact) indicators and EU Taxonomy.



- ICE offers quality data which is regularly checked and validated. This allows users to receive timely, consistent data with the EET standard.
- ICE's helpdesk is available 24/7, providing direct communication with the analyst team dedicated to EET collection, helping users to achieve their business goals.

## Delivery

All data contained on the EET can be provided in machinereadable formats (csv/xml/json):

- Daily, via data-feed (SFTP folder)
- Streaming, via our API/Web Service technologies

Data is also available through our web-based **Repository HUB** service, a user-friendly GUI which allows customers to download single EET documents and access their metadata & version history:
